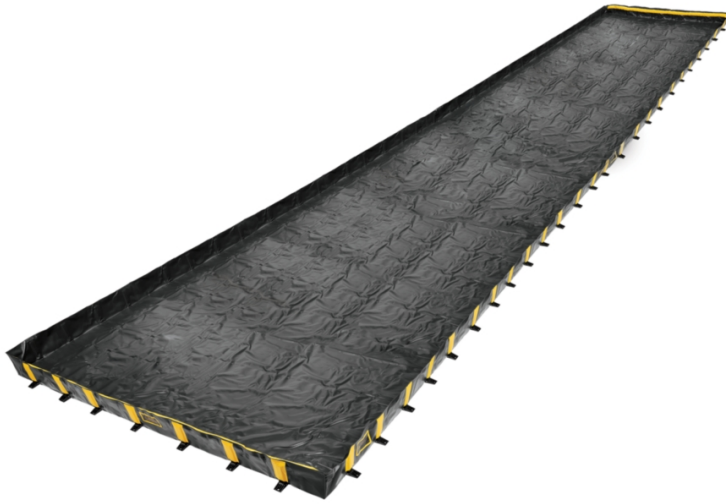


## PIG® Collapse-A-Tainer® Self-Rising Spill Containment Berm

- Brackets remain out of the way to avoid breakage from accidental impact or driveovers
- Folds to a compact size to let you store the system in a vehicle and transport it to a remote location; included strap secures unit in place
- Constructed of durable, XR-5 to resist chemicals, abrasion and tearing
- Grommets at each support hinge allow unit to be staked to the ground when needed
